**Subject : Proposed amendment of recruitment rules for Class-I Engineering posts in CPWD.**

**Ref : UD Ministry's File No. 28/4/09-S&D**

Madam,

At the outset allow me to say a few words about our Association. CPWD Engineers Association is the primary recognized association in CPWD by the Govt. for more than 4 decades, representing more than 3000 gazetted Group-B Assistant Engineers and promotee Group-A Executive Engineers and Superintending Engineers. Our Association is representing Civil as well as Electrical engineers and diploma as well as graduate engineers of CPWD except Class-I DR Engineers.

We are troubling you in the above subject matter only to bring out real facts for your consideration before taking a decision in the matter of recruitment rules of Class-I Engineers in CPWD, specifically with regard to the post of Executive Engineer. The brief synopsis in this regard is as under:

- (a) The original Recruitment Rules (RRs) were **notified on 21/05/1954** in which it was provided that **no Assistant Engineer Class-II shall be promoted as Assistant Executive Engineer, Group-A**. It is also provided that promotion to the Grade of Executive Engineer (EE) shall be made by selection from Assistant Engineers Class-II who would, but for age be qualified for admission to the competitive examination by the UPSC. In other words **only AEs possessing graduate in Engineering qualification be considered for promotion to the post of EE**.
- (b) **On 31/10/1972 a proviso was added** to the above RRs in which an **AE of "outstanding ability and record" can also be promoted to the post of EE in relaxation of the educational qualification**. This proviso was made due to the fact that there are **thousands of AEs who are only diploma holders** and there has to be some provision for their promotion to the post of EE.
- (c) When this proviso was not properly implemented by the administration during many DPCs, some graduate engineers have filed court cases which ultimately culminated in the Supreme Court, in the name of

**J.N.Goel V/s UOI in Civil Appeal No. 5363 of 1990 which was decided on 14/01/1997**, in which it was inter-alia decided that the proviso seeks to strike a balance between the aspirations, in the matter of promotion, of AEs having higher qualification and having lesser educational qualification but having outstanding ability and record. The Apex Court has categorically stated that **the proviso which enables a diploma holder AE to be promoted as EE does not suffer from vice of the arbitrariness**. The failure to implement the said proviso properly by the DPCs does not mean that the proviso itself is bad being arbitrary and there is no violation of Article 14 & 16 of the Constitution.

- (d) However, during the pendency of the above case the Govt. has **amended the RRs on 28/10/1996** in which a **quota system has been prescribed for promotion to the post of EE from three sources** i.e. **33 <sup>1/30</sup>% from AEs with 4 years regular service, 33 <sup>1/30</sup>% from AEs with 8 years regular service and possessing degree in engineering and 33 <sup>1/30</sup>% from AEs with 10 years regular service and possessing diploma in engineering**, i.e. 3 equal shares from 3 different sources.
- (e) **These RRs are in force till today**. But while making **ad-hoc promotions in the year 2006**, some **senior graduate AEs have been superseded by junior diploma AEs** from the common seniority list. Aggrieved by this, they went to Court through **OA 1674 / 2007** which was **decided by CAT, PB on 21/08/2008 by Three Judge Bench** stating that there is **no requirement for amending or interfering with the rules** but the senior graduate AEs would be entitled to promotion on the basis of their total length of service as diploma holders and the **preference given to the Junior diploma holder was not logical**. This order has been **implemented by the Govt.** and all such senior degree holders who also possess diploma in engineering, were promoted by holding a review DPC.
- (f) With the implementation of **6<sup>th</sup> CPC report**, the **grade pay of AE** has been **increased from Rs.4200/- to Rs.4600/-** and hence the minimum **eligibility service for degree and diploma AEs needed to be changed from 8/10 years to 7/9 years as per DoPT's instructions** in this regard. Moreover, to include the provision for **non-supersession of senior graduate AEs by junior diploma AEs** as explained in Para (e) above, a **proviso is required to be added** in the recruitment rules. ***The Urban Development Ministry has done the needful and proposed the modified recruitment rules maintaining the existing quota system from all the three sources but with lesser eligibility service as well as with the inclusion of the said proviso.***

With the above background, the proposed amendment in the recruitment

rules has been sent to DoPT by the UD Ministry in the above cited file under reference on 02/03/12 for your approval. But it is learnt by our Association that the DoPT is referring to its **handbook on recruitments rules published in the year 1993, quoting Para 3.10 of Schedule-B of the above guidelines** which provides that in the case of **senior Group-A post at the level of Executive Engineer and above the educational qualification should be insisted** upon in the interest of administrative efficiency **for scientific and technical posts** even though the same are not generally insisted upon in the case of promotion to posts of non technical nature. It is also learnt that the DoPT is thinking of making diploma holders AEs ineligible for the promotion to the post of EE, quoting the above guidelines even though the administrative ministry do not propose so.

It is a fact that **about 60-70% of the AEs** presently working in CPWD are **diploma holders** and by excluding them from being eligible to be promoted to the post of EE would **close all their promotional avenues** and they have to **retire as Assistant Engineer after 35 to 40 years of service** and getting **only single promotion from JE to AE**. Even at present for the promotion to the post of Superintending Engineer(SE) from the post of EE, one must possess a degree in engineering as minimum qualification and if diploma holders are further declared ineligible for promotion to the post of EE, **it will be great injustice to the large and majority chunk of AEs in CPWD**. Moreover with the **ACP scheme having been superseded by MACP scheme** their **financial up-gradation to the post of EE being granted earlier after 24 years of total service is already withdrawn** and they are going to **retire in the grade pay of Rs.5400/- after 30 years of service under MACPS**.

From the above, it can be clearly stated that the **diploma holder AEs who are already deprived of EE's pay scale after 24 years of service will further be deprived of their legitimate right to promotion to that post in their entire service life**. It is pertinent to mention that the **educational qualification prescribed for the post of Junior Engineer which is the feeder cadre for AE continues to be diploma in engineering only** and the earlier **proposal of UD Ministry to amend the same as degree engineering has not been acceded to by the DoPT and Department of Expenditure**. In the light of all the above facts, **it is earnestly requested** that the **proposal as received from the UD Ministry in the case of promotion from AE to EE may kindly be approved without any changes**, as the same will be **in the best interest of the department** and also will **cater to the legitimate expectations of all AEs in the department**. We hope your kind self we look into the whole issue and do the needful please.

Letter no. CPWDEA/F-7 / 27 dated 16/04/2012 written to **Shri Pranab Mukherjee, Hon'ble Minister of Finance**, Government of India, North Block, New Delhi.

Subject : **Great injustice to Assistant Engineers of CPWD in the modified ACP Scheme and pay scale by 6<sup>th</sup> CPC.**

Respected Sir,

Our Association is representing more than 3000 AEs and promotee class-I engineers of CPWD. There is a **huge stagnation** at the level of JE and AE in CPWD and it takes about **20-25 years** for getting a promotion. The ill-effects of such stagnation have been somewhat redressed by **ACP scheme by 5<sup>th</sup> CPC**, due to which we were getting **two financial upgradations in promotional hierarchy** after 24 years of service till 01/09/08. But for the first time in the history of the Central Government, the **6<sup>th</sup> CPC** has **modified** this scheme and replaced it **with MACP scheme** in which the sub-ordinate engineers of CPWD who were henceforth getting **Rs. 6600/- Grade Pay in PB-3** of Executive Engineer **after 24 years** of service have now been degraded to **Rs. 5400/- grade pay in PB-2 after 30 years** of service. To redress this injustice a **Special Career Progression Scheme (SCPS)** of CPWD is recommended by the UD Minister to DoPT / MOF in which granted benefits will continue. But the same is not acceded to.

Sir, in addition to the above injustice, the 6<sup>th</sup> CPC has also caused great imbalance in the initial pay scale of Assistant Engineers in CPWD and similar gazetted Group 'B' officers like Section Officers and Private Secretaries of CSS and CSSS cadres who were granted Rs. 4800/- grade pay and non-functional scale of Rs. 5400/- in PB-3 after 4 years of service. While recommending the pay scale of **Rs. 4600/- grade pay to AEs of CPWD**, the 6<sup>th</sup> CPC has totally ignored the duties and responsibilities and the arduous nature of work performed by them compared to Secretariat officers that too against Commission's own principles. AEs of CPWD deserve atleast **parity with similar cadres**, if not with AEEs.

Sir, both the above issues have been taken up by **Shri S. Jaipal Reddy**, Minister for Urban Development with the DOPT and Ministry of Finance during

his tenure and now by **Sh. Kamal Nath** with their **strong recommendations**. But the **injustice continues even today**. Hence, we request your kind self to look into the genuine grievances of our cadre and do the needful to redress the same at the earliest. We have high hopes in your vision, vast experience and sagacity and we pray for justice at your hands as you have done at the many times in many capacities. **We also request you to grant us a few minutes to explain our grievances in person please.**

Subject: **Promotion of AE to EE in diploma stream- filling up backlog ST Quota.**  
Sir,

You are well aware that **after May-2006 no ad-hoc promotion is made from AE to EE from diploma stream**, but promotions are made only from graduate stream all these years. The main reason being review DPC done during 2008 as per directions of Delhi High Court on yearly basis instead of lump sum basis during 2006, due to which the already promoted diploma holder EEs are found to be in excess of their quota. But at present the balance between diploma and degree quotas is even and any **further promotions from AE to EE against the vacancies of 2011-12 including cadre review posts** should be done on 1:1:1 basis only as per 1996 RRs. It is requested to kindly **hold the screening committee meetings** for the above vacancies at the earliest **from both diploma as well as degree streams.**

While making promotions in degree stream, the backlog of ST candidates has been taken care of by promoting LDCE – 1999 degree holder AEs of ST category during the year 2010 even though they did not have prescribed eligibility service of 8 years as on 01/01/2009. This has been done due to the fact that the **backlog was huge and by taking special relaxation from DoPT in the qualifying service** so that the ST category AEs promoted through LDCE in 1999 during the year 2001 are made eligible. The copy of relaxation granted by DoPT is enclosed for ready reference. We request you to kindly **take similar action in case of diploma holder AEs also, since as on 01/01/2011 they have not completed minimum prescribed qualifying service of 10 years as per RRs and promote diploma holder ST AEs**

**against the huge backlog vacancies falling in their quota.** Even otherwise, the Central Government has undertaken special recruitment drive to fill all such backlog vacancies and it is high time CPWD and UD Ministry also take proactive steps to fill the backlog vacancies of ST quota.

It is also a fact that the seniority list of AEs issued by the department in 2011 has been stayed by CAT PB, which allowed the department to operate and **make promotions based on 2002 seniority list** subject to outcome of the cases, till the disposal of the case. Hence it is also requested to make the promotions accordingly without waiting for disposal of the cases which is being delayed very much.

11.	How the LTC entitlements of fresh recruits are regulated in the first eight years ?	On completion of one year, the fresh recruit can be allowed 3 Home Town LTC and 1 All India LTC in each block of Four years in the first 8 years. <b><u>O.M. No. 31011/4/2008-Estt.A dated 23.09.2008</u></b>
12.	Whether Dependent Parents of fresh recruits can avail LTC for the journey from HomeTown to Headquarters and back?	No, the dependent parents of fresh recruits can not avail LTC for the journey from HomeTown to Headquarters and back.

13.	Whether claims for reimbursement can be allowed for road journeys by bus/taxi or other vehicle operated by private operators?	LTC Rules do not permit reimbursement for journey by a private car (owned/borrowed/hired) or a bus/van or other vehicle owned by private operators. LTC facility shall be admissible only in respect of journeys performed in vehicles operated by Govt. or any Corporation in the public Sector run by the Central or State Govt. or a local body. Rule 12(2) of CCS(LTC) Rules, 1988 read with- <b><u>Dopt's O.M. No. 31011/4/2008-Estt.A dated 23 September 2008</u></b>
14.	Whether airfare of children whose full fare is charged by the airlines is reimbursed?	If full fare has been charged by the airlines and paid by the government servant, the same will be reimbursed.
15.	Can a Govt. servant use the service of travel agents for LTC purpose?	Yes, but it should be limited to M/s Balmer Lawrie and Company and M/s Ashok Travels and Tours.
16.	What is the definition of family for LTC?	For LTC purpose family consists of (i) Spouse of the Govt. Servant and two surviving unmarried children or step children. (ii) Married daughters, who have been divorced, abandoned or separated from their husbands and widowed daughters residing with and wholly dependent on the Govt. servant. (iii) Parents and/or step parents residing with and wholly dependent on the Govt. servant. (iv) Unmarried minor brother as well as unmarried, divorced, abandoned, separated from their husbands and widowed sister residing with and wholly dependent on the Govt. servant provided their parents are either not alive and are

No reimbursement of LTC claims being restricted to the entitlement for journey between Headquarters and place of visit, the amount reimbursable in such cases is nil. <b><u>O.M. Subject: Prepration of zone of consideration for anticipated future promotions from the grade of AE(Civil) to the grade of EE (Civil) on ad-hoc basis.

Consequent upon creation of posts in the category of EE(Civil) on account of Cadre Review of Engineering Staff in CPWD, it is proposed to give effect this end in view, a zone of consideration (Degree holder) has been prepared. This list would form basis for effecting anticipated future promotions, subject to permission from Hon'ble Tribunal in ongoing cases or directions of the Tribunal in case of disposal on the issue of seniority of AEs (Civil) and is as under :-

<b>(B) Degree Holder Assistant Engineers (CIVIL)</b>
